

Public call for 1 temporary position at INGV, Department of Bologna, in the form of coordinated, ongoing working relationship; selection based on qualifications and interview.

In agreement with Article 7 of Legislative Decree no. 165/01 ("General rules concerning employment in public administration"), and subsequent amendments and additions, a public recruitment competition based on qualifications and interview is called in order to assign, in the form of a private contract, n. 1 temporary employment contract in the form of coordinated, ongoing working relationship.

## 1) Goal of the work

The goal of the work is the following: development of the Bayesian multi-risk model "ByMuR" and of an open-source software to analyze and visualize the results, within the project "ByMuR" – FIRB – FUTURO IN RICERCA.

#### 2) Effective date, duration and termination of contract

The contract will have duration of 3 years, starting from the 01 December 2010. The contract can be terminated by the administration at any time without obligation to specify the reasons and without notice.

## 3) Wage

The global wage is set to Euro 90000,00 (ninety-thousand/00) for the whole contract period, including taxes and Social security. It will be paid in monthly postponed instalments, given the acquirement of the project manager's formal statement declaring the regular implementation of the work and its conformity with contract's obligation.

## 4) Requirements

In addition to requirement of the Public Italian Administration, the candidates need to fulfil the following requirements to be admitted to the selection:

- a) be an Italian or European Union (Communitarian) citizen;
- b) be a less than 33 years old researcher on the 19th December 2008;
- c) have obtained a PhD degree before the 27th February 2009;
- d) have knowledge on hazard and/or risk assessment, preferably in Bayesian Inference analyses:
- e) be able to programme, preferably with Python, Fortran, Matlab;
- f) be able to speak English (at a good level);
- g) for non-Italian European Union (Communitarian) citizens only, provide a statement on being

able to speak Italian (at a basic level);

h) must not have penal sentences or pending penal procedures.

# 5) Application form

The application form, written up in plain paper following the form in attachment, and signed from the applicant (not fulfilment of such requirement implies the exclusion from the selection), should be sent <u>exclusively</u> either to the certified email address <u>aoo.bologna@pec.ingv.it</u>, or through certified mail with return receipt ("raccomandata A.R."), or through express courier, **within and not later than 15 days** after the day after the publication of the present call in the "Albo ufficiale" and on the website of INGV (www.ingv.it), to the following address:

To certify the timing of the submission, it will be considered, for applications send by certified mail, the date on the stamp of the local post office, while for applications send by express courier delivery by the sending date reported on the accompanying letter.

The forms sent though certified email will be accepted until the 1200 of the 15<sup>th</sup> day from the call.

The INGV Administration does not assume any responsibility for lost communications depending either on incorrect or unclear anagrafic data, or address, or lost/late communication of changes in the address reported in the application form, neither for possible delays or problems in postal or telegraphic services or, in any case, for reasons due to third part, casualty or major force.

In the application form, the candidate must indicate, under his/her own responsibility:

- 1) name, surname, date and place of birth, and fiscal code (for non-Italian European Union (Communitarian) citizens, the passport number);
- 2) to be an Italian or European Union citizen;
- 3) to fulfil all the cited requirements;
- 4) to not have penal sentences or pending penal procedures;
- 5) a list of his/her qualifications;
- 6) an address for communications from INGV Administration.

# 6) Acceptable qualifications

For the evaluation of the qualifications by the Evaluation Commission, the candidate must attach to the application the following documents:

- a) a signed copy of the curriculum vitae, indicating the education and professional experiences acquired:
- b) other documents and qualifications that the candidate believes valuable.

The qualifications do not need tax stamp and they can be evaluated only if related to the subject of the present call, under the unquestionable judgement of the Evaluation Commission. Instead of original documents, it is admitted to present substitutive declaration of certifications, according to the Art. 46 of the D.P.R. 28.12.2000, n. 445.

## 7) Evaluation

The evaluation of qualifications and the interview, which will be about the knowledge and professional experiences of candidates, will be done by a Commission of experts nominated from the Director of Department of Bologna of the INGV.

The interviews will be held Thursday 11<sup>th</sup> November 2010, at 10.00, in the INGV Department of Bologna, via Donato Creti n. 12, Bologna.

The convocation for the interview will be sent to the email address reported by the candidate in the application form.

At the end of the evaluation procedure, the Commission will send the relative notes to the Administration in which the merit ranking will be highlighted.

# 8) Contract drawing and expiration

Unless impediments, the selected candidate will be invited to sign a specific contract of Private Right in which it will be reported:

- a) starting date;
- b) the goals of the work;
- c) the wage:
- d) any other information regarding the development of the work.

The signed contract is not configured as employment and it is not subject to ordinary employment conditions, such as severance pay, holydays, indemnity and compensations own by jobs carried out to the dependencies of Public Administration.

The worker will carry out his/her own activity without hierarchical ties and in full autonomy.

## 9) Protection of privacy

The candidate's personal details will be treated according the laws n. 196/2003, and subsequent amendments and additions, only for the goals of administration of the recruitment procedure.
