### Call for the selection for provision of research contract

#### The Director

Having regard to the Legislative Decree 29/9/1999, n. 381;

Having regard to the Legislative Decree 31/12/2009, n. 213 on the "Riordino degli enti di ricerca in attuazione dell'art. 1 della legge 27 settembre 2007 n. 165";

Having regard to D.P.R. 28/12/2000 n. 445 and following integrations and modifications "T.U. delle disposizioni legislative e regolamenti in materia di documentazione amministrativa";

Having regard to Legislative Decree 30/06/2003, n. 196, on the "Codice in materia di protezione dei dati personali";

Having regard to Minister Decree n. 102 del 09/03/2011, on the definition of the minimum salary for Research Grants:

Having regard to the directive of the Public Administration and Semplification Ministry n. 14/2011 for the application of the new rules on the equivalent certificates and declarations of 'art. 15 of the law 12/11/2011, n. 183;

Having regard to the INGV Rules for the provision of Research Grants issued with Resolution n. 17/2012 of 04/04/2012;

Given the request for the activation of a selection for the provision of research grant in the frame of H2020 "EUROVOLC – European Network of Observatories and Research Infrastructures for Volcanology project by Laura Sandri, approved by Ufficio Affari Amministrativi e del Personale, dated 25/07/20188, pro. n1697;

Given the funding available for such Project,

Having regard to the selection n. 3/2018, decree n. 81/2018, prot. n. 0013019 dated 04/09/2018 for the provision of research grant for 24 months in the frame of H2020 "EUROVOLC;

Considering the completion of the entire competition procedure, which ended with the decree n 104/2018, prot. n. 0017694, of approval of the merit ranking and declaration of the winner of the competition;

Given the renunciation of the winner received on November 25, 2018;

Considering that on other candidate had passed the competition procedure, so no other name was listed in the merit ranking (decree n 104/2018, prot. n. 0017694); Considering the persistent need to find professionalism for carrying out the project activities; Given the timing of the project and therefore the need to reduce the contract months from 24 to 19 months

#### **DECREES**

A public competition based on qualifications and interview (in videoconference upon request) for the provision of n.1 research grant ("PostDoc" typology), duration of 19 months, to be carried out at the Istituto Nazionale di Geofisica e Vulcanologia – Sezione di Bologna.

# Art. 1 Subject of the research

The research to be carried out is: Survey and integration of pre-existing methods for quantitative volcanic hazard assessement, and application to a test volcano".

The goal of the research is the set up of a scientific basis for easing volcanic hazard assessment and the understanding of its output.

The requested activities will be the followings:

- 1) compilation, and implementation in an online searchable catalog, of an updated list of pre-existing and freely-available tools and/or softwares for volcanic hazard assessment;
- 2) application of a selection of such tools to evaluate volcanic hazard at a project test-volcano (to be identified among European and overseas-territories volcanoes), and quantitative comparison of the results obtained by different tools;
- 3) development of innovative methods to improve the accessibility of volcanic hazard evaluation, for example by integrating preexisting tools, and their application to European volcanoes.

The research activity will take place at the Bologna office.

# Art. 2 Start, duration and salary

The annual gross salary is Euro 22.272.00 (twenty two thousand two hundred seventy two, 00) Allowance apply, in tax matters, the provision of the art. 4 of the Law 13/08/1984 n. 476 and successive modifications and integrations; in social security matters, the provision of art. 2 par. 26 and followings, of Law 8/08/1995 n. 335 and successive modifications; in maternity leave, the provisions of the Decree of Ministry of Labour and Social security 12/07/2007; in occupational disease matters, art. 1 par. 788 of the Law 27/12/2006 n. 296 and successive modifications.

The contract has a duration of 19 months, subject to annual verification of the activity carried out.

# Art. 3 Requirements for eligibility

Applicants for the position must meet the following criteria, or will be excluded from the selection process:

- a) an advanced degree (M.Sc. or equivalent) in Earth sciences, geophysics, physics, mathematics, engineering or informatics, equivalent to the Italian title;
- b) PhD in Geophysics or Earth Sciences;
- c) knowledge and experience in the study and evaluation of volcanic hazard, to be assessed during the interview;
- d) good English, to be assessed during the interview;

Omission of even one of the above requirements implies exclusion from the selection.

Candidates must have their qualifications by the selection announcement deadline.

Qualifications obtained abroad that are not previously and officially recognised in Italy will be considered by the Selection Board only for the aims of this selection.

The INGV guarantees equal gender opportunities for the provision of grants, as well as the protection of confidentially of personal data according to the current laws

## Art. 4 Incompatibilities

The following qualifications involve exclusion from the selection procedures:

- have a permanent position at a public University, Institute or Research Centre; or permanent

position at ENEA or at the Italian Space Agency; or a permanent position at one of the other institution referred at art. 22, parl, of the Law n. 240/2010; or permanent position at an institution providing diplomas that are regarded as being equivalent to a doctoral degree according to art. 74, par 4, of the D.P.R. n. 382 of 11/07/1980;

- be a research grant holder employed by a public administration different from those listed at the previous point or employed by a private company, in case such research grant is not interrupted or suspended through unpaid leave for the entire duration of the present contract;
- be an employee at INGV, either with or without permanent position;
- be enrolled in degree programs, Ph.D courses providing a grant; University masters, either in Italy or abroad;
- The present research grant cannot be combined with others grants provided by INGV or by other research institutes.

# Art. 5 Application for Admission

The application form (Attachment A) should be signed by the applicant (unsigned application will be excluded from the selection) and sent to INGV Sezione di Bologna no later than **15th days** past the day of the publication of this call on the official website of INGV (www.ingv.it) and on the MIUR "Albo Ufficiale":

- 1) as a signed pdf file to the email address <a href="mailto:aoo.bologna@pec.ingv.it">aoo.bologna@pec.ingv.it</a>, using a PEC email. The email must report the following subject: "Selection for Research Grant n. 3/2018 Sezione di Bologna". Day and time of receipt of INGV PEC email will be used to certify the correct arrival date with respect to the deadline;
- 2) only extra UE resident citizens or resident in Italy but not allowed to use PEC email, may send the application using a no-certified email address to <a href="mailto:aoo.bologna@pec.ingv.it">aoo.bologna@pec.ingv.it</a>.

The application form must (a penalty of exclusion) also contain the email address to which the candidate asks to receive all the documents and information related to the selection.

The INGV administration does not assume any liability for failure or delay in notifying change of address in the application, nor for any communication delays attributable to third parties, unforeseeable circumstances or force majeure. Changes in the communicated email address should be immediately notified to the INGV's Bologna Administration exclusively by email at following address: sonia.vivanelli@ingv.it.

Disable candidates should indicate the requested support in the application for admission.

In the application, the applicants must declare, under their own responsibility, and subject to exclusion from the selection in case of failure:

- 1) full name, date and place of birth, residence and citizenship;
- 2) Italian tax payer's code (for Italian citizens or foreigners provided)
- 3) educational qualifications, including evaluation, date and University at which they were obtained:
- 4) to have no criminal convictions and no pending criminal proceedings. Otherwise, indicate the ongoing proceedings and the sentences passed, the dates of judgments and judicial authority which issued:
- 5) to possess the requirements at point 3) of this document, from letter a) to d)
- 6) to possess political rights (only for citizens of the European Union)
- 7) not to be employed by a public institution or private company, and in any case, not to receive a grant in Italy or abroad; in the case a grant is instead received, to engage to produce documentation attesting to the suspension of the grant before the date of start of the research

contract and for its entire duration.

The following documents must be attached to the applicant form:

- 1) curriculum vitae et studiorum, signed and dated in every page;
- 2) list of titles attached if any;
- 3) a clear, legible photocopy of the passport or other identity card which contains a photograph and which is recognised by the European Commission. This copy is essential for identity verification during the interview;
- 4) email address where the candidate can be contacted
- 5) Only for EU member citizens must fill the statement made under Art.s 46 and 47 of the D.P.R 28/12/2000 N. 445 (Attachment B).

### Art. 6 Titles for evaluation

The Selection Board will evaluate the Curriculum vitae et studiorum, in Italian or English, that should specify any facts and qualities including level of knowledge of English. The CV must include the followings:

Studies undertaken and qualifications obtained with the relative dates and evaluations;

The duties, functions performed, the position held and their duration;

Any other technical, scientific, didactic or professional activity and experience;

List of scientific publications, technical reports, monographs, books, book chapters, patents, etc;

Any other supporting documents that the applicant considers may be relevant for evaluation.

EU Member State citizens must declare that the information posted in their CV is true and accurate, by compiling the form in attachment B.

The titles declared in CV should be documented according to the following:

- Publication, technical reports, monographs, books, book chapter, patents, etc, should not be attached to the application form if they are available in the web or they are identified through a d.o.i. number; in such cases the exact web address or the d.o.i number should be provided. Publications, technical reports, monographs, books, book chapters, patents, etc including degrees thesis that are sufficiently described in the CV will be evaluated based on that description, even if prepared in language different from Italian or English, without need to be attached;
- ☐ For any other document:

for European citizens: documents and titles provided by public administration of a Member state of the European Union should not be attached, rather, they should be listed in declaration form provided as Attachment B. Copies of documents and titles provided by public administration of a non-Member state, as well as of document and titles provided by private companies, should be attached. Attached title must be listed in the declaration form provided as Attachment B. documents and title provided in a languages different from Italian or English should be supported by a translation I English.

For non-European citizens regularly residing in Italy: documents and titles provided by Italian public administration may no be attached, but listed in the declaration form provided as Attachment B. Copies of documents and titles provided by public administration of a non-Member State, as well as of documents and title provided by private companies, should be attached. Document and titles provided in a languages different from Italian or English should be supported by a translation in

English.

For all other non-European citizens: copies of documents and titles should be attached (also in digital format). Document and titles provided in a languages different from Italian or English should be supported by a translation in English.

False declarations shall be punished under the Penal Code and corresponding special laws according to the art. 76, of D.P.R 445/2000. INGV, according to art. 71 and following arts. 75 and 76 of D.P.R 445/2000 and following integrations and modifications verifies the correctness of the declaration provided.

### Art. 7 Exclusion from the selection

Candidates are admitted conditionally to the selection. The Director of the INGV Sezione di Bologna can exclude from the selection a candidate on the basis of rightful motivations at any time. The exclusion will be communicated to the candidate.

#### Art. 8 Selection Board

The Selection Board is appointed by the Director of the Sezione di Bologna, and is composed of three members chosen among researchers, technologists and experts from INGV or from outside it, one with the role of Selection Board President and one with the role of the Recording Secretary. The Recording Secretary may be selected among the members of the Selection Board.

## Art. 9 Selection modalities

The Selection Board establishes in its first meeting the criteria and the procedures of evaluation of candidates, qualifications and interviews, the latter aimed at evaluating the candidates background and the knowledge of the research themes stated at art. 1 of the presents titles and knowledge in English. Candidates must bring a valid identity document in order to be interviewed and will be excluded from the selection procedure in case they do not show up at the time previously communicated by the selection Board.

The interviews will take place at INGV Sezione di Bologna, via Donato Creti, 12 Bologna, Italy, unless the candidate requests a remote interview.

Remote interview through videoconference (Skype e.g., with webcam) can be requested by candidates in the application form, where a valid SKYPE account must be indicated. The interview will be preceded by official identification of the candidate, who will need to display the same passport/ID provided with application.

In the same day of the interviews the Selection Board prepares a ranked list based on the results of the interview of each candidate, in decreasing order, starting with the candidate with highest results.

# Art. 10 Ranking of candidates and awarding of the researcher contract

The selection Board prepares a merit ranking by summing the ranks from the titles and from the interview for each candidate; this is presented in decreasing order starting with the candidate with highest result.

The merit ranking is approved with a specific act of the Director of Sezione di Bologna published on

the website of INGV.

Within 15 days from the publication of the final results, INGV General Director communicates to the successful candidate the assignment of the research grant. The successful candidate must deliver within 15 days from notice of grant assignment and under penalty of forfeiture, a declaration of acceptance in Italian or English, in plain paper, in which it is stated that none of the incompatibilities stated at art. 4 hold.

A successful candidate who fails to communicate acceptance of the job within the requested deadline, or who is not present on the day of start of the grant is revoked from office. Delays in the date of start of the job can only be accepted in case of duly certifies medical reasons, maternity leave duly certified.

The appointment is conferred with private contract, it does not represent an employment relationship and does not give rights regarding access to employment position at INGV.

# Art. 11 Rights and responsabilities

The appointed researcher should comply to rules and regulations approved by INGV for this kind of research grants.

Research activities will be developed in the frame of the European Project EROVOLC, funded by the European Commission.

To the aims and objectives of the foreseen activities, the appointed researcher has full access to the infrastructures, instruments and services at their appointment structure, according to the applicable rules and regulation approved by INGV.

In case of work trips in the frame of the planned research activities, and subject to written authorisation by scientific responsible and of the Section Director, the related cost will be reimbursed according to the criteria and model established by the current regulations.

The research activities can be partly carried out at a University or Research Organization abroad at obtaining specific certification, provided this is consistent with the programs and goals of the research assigned to the assignees; the period spent abroad must be previously and expressly authorized by the Section of Bologna on the motivated proposal of the Scientific Responsible.

### Art. 12 Forfeiture and termination

Procedures for termination of contract can be started at any moment during the appointment in case the granted researcher fails to regularly and continuously prosecute their activities without justification, or if the granted researcher is responsible of serious and repeated failures or shortcomings. Those termination procedures require duly motivated requested by Scientific Responsible approved by the General Director.

## Art. 13 Advertisement of the selection process and Final Rules

The present call is advertised on the INGV official board and by publication on the website of INGV and MIUR. For matters not covered in this announcement, reference is made to the applicable laws and regulations.

For what is not provided for in this announcement, reference is made to the current laws and regulations in force.

The data obtained for this selection process is necessary for the administration of this selection announcement in accordance with Law n. 196/20032 and following integrations and modifications..
